<b>Payment Options</b>	<p><b>Option 1: Online</b>  <b>*Must Use a Computer to Pay Cell Phones DO NOT Work</b></p> <p>The easiest way is to pay electronically. Your payment will automatically be calculated. Go to CMAC Sorors Only webpage via <a href="http://CMACdeltas.org">CMACdeltas.org</a> website. If you do not have an account, create one. This will give you access to all CMAC business. <i>Note: WIX charges a fee per transaction. For Regular Members, the fee for non-AMEX is \$11.65 and for AMEX is \$14.93. For Life Members, the fee for non-AMEX is \$5.95 and for AMEX is \$7.47. <b>What to Expect Next</b>	<ol style="list-style-type: none"> <li>1. When your mailed payment has been received, you will receive an email confirmation.</li> <li>2. CMAC will process your dues / enter your information into the Red Zone. <b>Note:</b> CMAC must wait for National Headquarters to put you on our Financial Roster.</li> <li>3. Once on the Financial Roster you will begin to receive CMAC email.</li> </ol>
